- Ensuring that the actions to be taken are as per the guidelines of the relevant regulations as laid down by the regulatory bodies.
- Timely circulation of action taken report to the concerned authorities against Anti-Ragging in the institute.
- To prevent and eliminate incidents of ragging within the college premises and hostels, as well as in the neighbourhood.
- To create a safe and supportive environment for students by strictly enforcing a zero-tolerance policy towards ragging.
- To sensitize students about the harmful effects of ragging and the disciplinary actions that will be taken against offenders.
- To promote a culture of respect, empathy, and camaraderie among students.

### **Functions/Responsibilities:**

1. Disseminating information on the consequences of ragging through orientation and awareness programs.
2. Forming and deploying an anti-ragging squad to regularly monitor the campus, and neighbourhood.
3. Implementing pre-emptive measures to prevent ragging incidents from occurring.
4. Investigating complaints related to ragging promptly and impartially.
5. Taking appropriate disciplinary actions against individuals found guilty of ragging, which may include expulsion, suspension, or legal action.
6. Publicizing the contact information of the committee members for easy reporting of incidents.
7. Periodically reviewing and updating the anti-ragging policy to ensure its effectiveness.
